

## **Amendment to Vendor Agreement between Texas Council on Family Violence and Brazos County**

*All terms and agreements created by this amendment are conditioned upon TCFV's receipt of State or Federal funds allocated for the payment of such obligations. I understand in signing this document that these funds are yet to be in receipt and TCFV will notify me at such time they are and move to execute payment. Further I understand that this agreement may be terminated in writing if funds are not allocated to TCFV.*

The Texas Council on Family Violence (TCFV) and Brazos County (hereafter "Vendor") previously entered into an agreement related to the Domestic Violence High Risk Team Project on January 1st, 2022. This is the first amendment to the Grantee Agreement fully executed in January of 2022. This amendment serves to revise the Agreement terms and extend the date of the Vendor Agreement. The amendment supports continued efforts to enhance the collaboration between local Domestic Violence High Risk Teams in support of survivor safety. This amendment does include additional funding from TCFV in the amounts and dates specified below.

### **Contract is amended as follows:**

- A. The term of the contract will commence on January 1, 2022 and end August 31<sup>st</sup>, 2023.
- B. Additional compensation will be offered in the following time schedule:
  - a. Fifth installment of \$13,750 distributed on 12/1/22 upon receipt of the DVHRT Quarterly Grant Report.
  - b. Sixth installment of \$13,750 distributed on 3/1/23 upon receipt of the DVHRT Quarterly Grant Report.
  - c. Seventh installment of \$13,750 distributed on 6/1/23 upon receipt of the DVHRT Quarterly Grant Report.
  - d. Eighth installment of \$13,750 distributed on 8/31/23 upon receipt of the DVHRT Quarterly Grant Report.
- C. Quarterly report deadlines are required as outlined below.
  - a. Q.1 Due 11/30/22
  - b. Q.2 Due 2/28/23
  - c. Q.3 Due 5/31/23
  - d. Q.4 Due 8/31/23
- D. TCFV contact for agreement and programmatic purposes will be David Scott. If an alternate point of contact is designated, the Vendor will be notified in writing.

TCFV and Vendor reaffirm no other terms or conditions for the above-mentioned original agreement are not hereby otherwise modified or amended shall be negated or changed. All other terms of the Vendor Agreement and prior amendments, if applicable, remain in full force and effect.

By signing this Amendment, and based on mutual consideration, I hereby understand and agree to the above conditions as listed. The below signatures will act as a final confirmation of both parties' agreement to amendment terms, unless discussed and agreed in writing otherwise. Through my signature, I attest I and/or my company/organization is not debarred, suspended or otherwise deemed ineligible from receiving federal and state funds.
