Mr. Hamlin stated that yes they are working on digitizing those records.


Commissioner Berry said she would like see the gymnasium used for other purposes.

There were no citizens present to offer commentary for or against the proposed plan.



September, 2017, in Bryan, Brazos County, Texas.







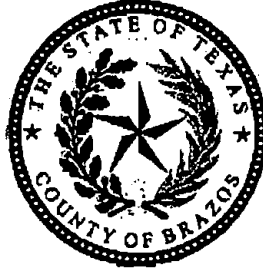
